Purchaser certifies that all statements made in this agreement are for the purpose of obtaining ELECTRONIC CHECK approval and are true and correct. Purchaser confirms the acceptance of the terms and conditions of sale as set forth in this agreement, BWI invoices, monthly statements and catalogs. Purchaser expressly agrees to make payments in full to BWI for all purchases in accordance with these terms and conditions of sale. Purchaser agrees that BWI terms and conditions supersede printed statements or conditions specified on any purchase order unless prior written notification from purchaser is received by BWI terminating this agreement. Purchaser must give written notice to BWI of any changes of information contained herein. Purchaser acknowledges the ELECTRONIC CHECK option is an extra service provided by BWI and will be charged a fee per transaction. The fee will be quoted to Purchaser at the time of purchase. Any check returned by the bank for nonpayment will be assessed a \$30.00 fee. Purchaser acknowledges that all open invoices over 30 days from the invoice date may be assessed a late fee at the maximum allowed by law. Purchaser agrees to pay reasonable attorney fees and all other costs and expenses incurred by BWI in the collection of any obligation of the purchaser pursuant hereto. Purchaser is aware that all sales originate in the State of California and agrees that the laws of California apply. This agreement once accepted by BWI shall remain the sole property of BWI and may be terminated "at will" by BWI.
